Benzylbutyl (BBP)	0.1% by weight on homogeneous material*

* by « homogeneous material » we mean a material of uniform composition or a material consisting of the combination of several materials that cannot be divided or separated into different materials by mechanical actions such as unscrewing, cutting, crushing, grinding and abrasive processes.
